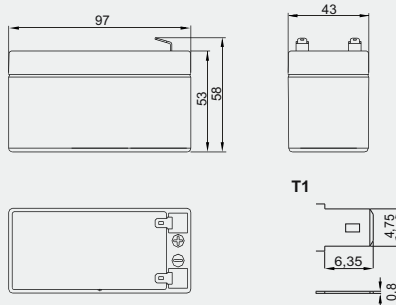

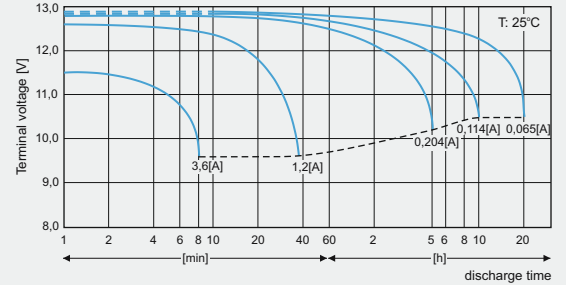

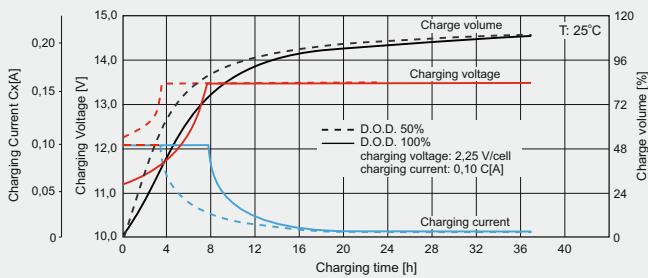

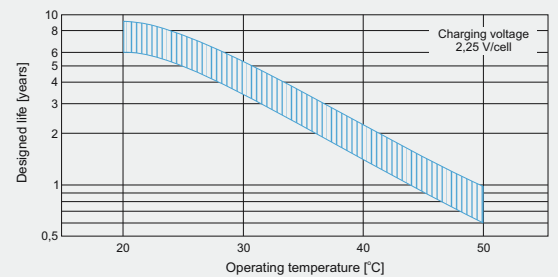
#### DISCHARGE CHARACTERISTICS



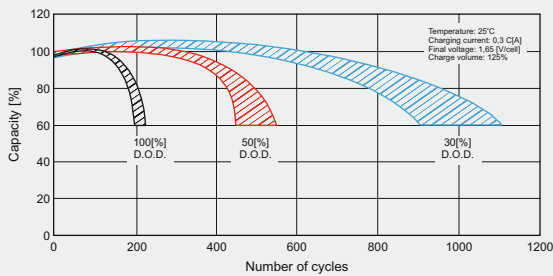
#### CHARGE CHARACTERISTICS



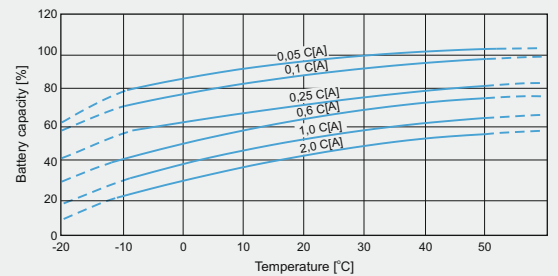

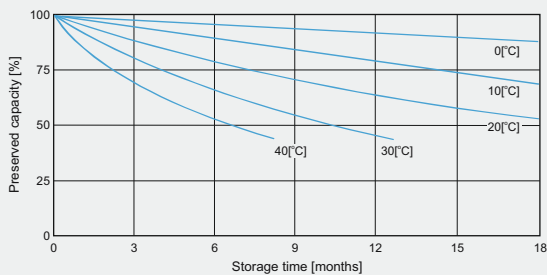
#### CYCLIC LIFE
